

UTS Prize Conditions of Award Emerson Health Outstanding Achievement Prize

Faculty: HEALTH

This document sets out the conditions of award for the below Prize ('Prize') as well as the obligations of recipients ('Recipient') and UTS in regards to this Prize. The administrative processes to support awarding this Prize will be managed, and may be amended, in accordance with UTS Rules, Policy and Procedures.

1. PRIZE NAME: Emerson Health Outstanding Achievement Prize

2. PURPOSE

The aim of the Emerson Health Outstanding Achievement Prize is to reward students who have demonstrated outstanding performance in the face of adversity.

3. VALUE AND BENEFIT

3.1 Number of Recipients:

One (1) new Recipient will be awarded the Prize each year. Note: In 2022, two (2) recipients will be awarded the Prize.

3.2 Benefit/s to Recipient:

• The maximum value of the prize is \$1,000 to the recipient.

3.3 Payment of benefit/s:

• Each Recipient will receive one (1) payment of \$1,000 by electronic funds transfer to their nominated bank account and a certificate of award.

4. ELIGIBILITY CRITERIA

To be eligible for the Prize, a candidate must meet all of the following criteria:

- Be enrolled full-time or part-time in in one of the following UTS degrees:
 - Masters of Health Services Management
- Submit a short video (maximum 2 minutes) informed by the applicant's personal experiences and education to date and focusing on how they would improve the Australian health care system.
- Submit a written statement (maximum 600 words) describing a considerable challenge faced whilst studying and how it was overcome.

5. RECIPIENT SELECTION CRITERIA

As evidenced by the submitted video and written statement:

- Strategic vision for creating and driving improvement in the Australian health care system
- Resilience and demonstrated ability to achieve excellence despite adversity
- Academic Performance in current UTS course (WAM at the time of selection) may be taken into consideration

6. SELECTION

The Prize will normally be open for applications from April each year (closing in September) with the selection committee being held in October of the same year.

The applications will be reviewed by a Selection Committee chaired by the Director, Centre for Health Services Management (or nominee) and will include a minimum of two other people with at least one UTS staff member, and may include the Donor or Donor's representative.

The Recipient(s) will be approved by the Chair of the Selection Committee.

7. OTHER CONDITIONS

• Previous prize recipients and entrants are eligible to enter in following years.

8. FUNDING

8.1 Internal UTS funding: None.

8.2 External Funding:

Donor funding has been secured for four years. Annual funding is \$1,000. The funding arrangements are stated in the Gift Agreement drawn up between the Advancement Office and the Donor.

This Prize will be offered in 2022 and be reviewed for renewal in September 2025.
