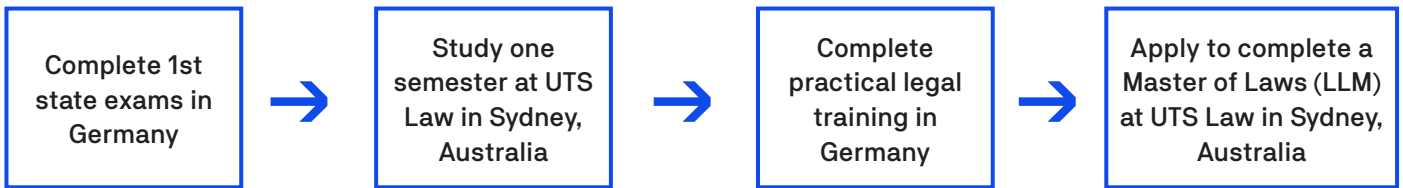

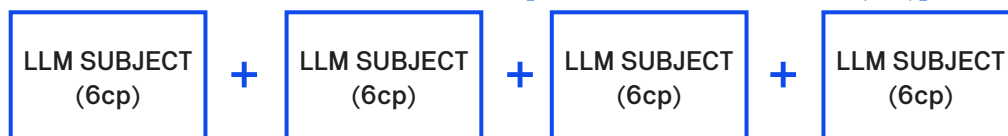
Study in the heart of one of the world's great global cities
