The Chair commended the phenomenal work that has been undertaken by UTS and the Centre for Social Justice and Inclusion, in promoting UTS's commitment to social justice, as reflected in the Social Justice Report.

# \*2.2 REPORT FROM THE VICE-CHANCELLOR

#### **RESOLVED AB/20-3/42 – Report from the Vice-Chancellor**

Academic Board to receive and note the report as detailed in Document 2.2 – *Report from the Vice-Chancellor*.

#### Note for the record

The Vice-Chancellor acknowledged the efforts of all UTS staff (and the Academic Board members) and thanked Academic Board members for their continued leadership and support.

The Vice-Chancellor advised members to read the Social Justice Report, as it underpins and reinforces all the work that UTS does. It is reassuring to see that the wonderful work in the social justice space continues, even during these challenging times.

The Vice-Chancellor spoke to his report, highlighting the following and noting that the rest of the report be taken as read.

- **Campus reactivation:** UTS has entered Phase Two of the campus reactivation plan. From the start of Spring session on 27 July 2020, building access has been widened, and most critical face to face learning activities (including labs, practicums, group work, studios, etc) will be returned to campus in face-to-face mode. UTS's primary focus remains the health and wellbeing of its staff, students, and the broader community. Lot of effort has been put into ensuring that these on-campus activities are undertaken in a safe and low-risk environment and various safety protocols are in place to maintain social distancing.
- **Teaching and learning during Spring webinar:** Over 800 staff members attended the webinar, which focused on providing information on health



and safety for learning activities in Spring 2020. There have been numerous requests from students to change classes from 'face to face' to 'online' mode, as some students are anxious about their safety in attending the campus in the current COVID-19 environment. It was noted that there are extensive measures and protocols in place to mitigate this risk. Academic Board commended the incredible work being undertaken by the cleaners in helping keep the UTS community safe.

- **COVID-19 impacts and response website:** The Vice-Chancellor advised Academic Board members to visit the COVID-19 impacts and response website regularly and direct their colleagues to do the same. UTS is responding to the COVID-19 pandemic, following NSW and Commonwealth Government advice. This page provides updated information about studying at UTS in Spring 2020, access to the UTS campus and what UTS is doing to keep the community safe.
- Congratulations: The Vice-Chancellor congratulated:
  - the awardees of the Order of Australia in the recent Queen's Birthday 2020 Honours: former deputy vice-chancellor (international), Emeritus Professor William Purcell (for significant service to tertiary education, business, and Australia-Japan relations) and the immediate past chair of the UTS Australia-China Relations Institute Advisory Board, the Honourable Philip Ruddock (for his distinguished service to the people and Parliament of Australia and local government)
  - the Chief Data Officer, Craig Napier, who was ranked third in the Institute of Analytics Professionals of Australia (IAPA) 2020 Top 25 Analytics Leaders.
- Appointment to Federal Government working groups: The Vice-Chancellor was appointed as:
  - a member of the Research Sustainability Working Group, which will provide advice about sustainable approaches to research funding for universities during COVID-19 and beyond
  - the Chair of the National Priorities and Linkage Fund Working Group, which will help design the Government's \$900 million National Priorities and Linkage Fund (fund) to enhance engagement between higher education and industry, with a strong focus on Science, Technology, Engineering and Mathematics (STEM) industries.
- NSW Framework for a secure corridor for international students: The NSW government understands the critical role international students play in NSW economic activity and recovery. NSW Vice-Chancellor's Committee Working Group (includes UTS representation) has been collaborating with NSW Treasury to establish a secure corridor for international students to re-enter NSW, subject to health and other



requirements being met, is being considered. The Federal Government has announced that:

- the government will recommence granting student visas in all locations lodged outside Australia so that when the borders reopen, students will already have visas and be able to make arrangements to travel
- current student visa holders studying online outside Australia impacted by COVID-19 will be able to use that study to count towards the Australian study requirement for a post-study work visa, which is a welcome move and would have positive implication, both for students and for UTS's finances.
- University rankings: UTS ranked 133 in the QS Rankings, the top 12 per cent of institutions for performance. The Leiden world ranking of universities places UTS as number one in Australia for the proportion of its research appearing in the top 10 per cent of most-cited publications in scientific fields, also placing UTS in the world's top 60.
- *ICT Sovereign Procurement Taskforce:* The NSW Government established an ICT and Digital Sovereign Procurement Taskforce, chaired by Mr Murray Hurps, Director, UTS Entrepreneurship to help develop strategies and policies that will support:
  - enabling increased number of government supply opportunities targeting small and medium enterprises (SMEs) and the potential for increased spend on SMEs. This will include indigenous suppliers, start-ups and disability suppliers.
  - ensuring SMEs can compete on an equal footing in ICT and digital procurement activities.
- Value of our experts in the media: One of the critical ways UTS serves society is through providing informed expert commentary on issues that affect Australia. It has therefore been very pleasing to see that during COVID-19, the contribution of our experts has jumped five-fold.

Academic Board discussed the role of UTS in Tech Central precinct, the world-class innovation and technology precinct emerging in inner-Sydney, which will be home to start-ups, scale-ups and innovation ecosystem partners. As a university, UTS is rightly placed to contribute to Tech Central by providing opportunities for people to collaborate, establish start-ups, conduct important research, and set young people on the path to the jobs that will move Australia forward. UTS is working with NSW Government on numerous initiatives to activate the precinct, even before the buildings are open. An update on the initiatives was provided.

Academic Board discussed that while supporting national priorities (like supporting low socio-economic status (SES) and Indigenous students) is important, the Australian Higher Education Relief Package and government interventions to shift focus to national priority areas (like nursing, teaching,



counselling, allied health) may pose a risk of students being deprived of the freedom to choose their subjects to help support their career choices. With the shift of funding to national priority areas, the other excluded areas are impacted. It was noted that universities have an important role to play in providing the community with relevant skills to map out the economy, post COVID-19, especially in collaborating with industry to upskill workforce.

Academic Board discussed the changes made to the admissions process for Higher Secondary Certificate (HSC) students, to respond to the impact of COVID-19. The Provost noted that the changes include consideration of Year 11 results in addition to the Australian Tertiary Admission Rank (ATAR), and expansion of Schools' Recommendation Scheme. Further information on these changes will be made available at the next Academic Board meeting.

#### 3 PRIORITY ISSUES

#### 3.1 UTS 2027 strategy

#### RESOLVED AB/20-3/43 – UTS 2027 strategy

Academic Board resolved to receive and note the presentation on UTS 2027 strategy.

#### Note for the record

Academic Board received a presentation from the Provost Professor Andrew Parfitt on UTS 2027 providing an overview of how some of the UTS 2027 initiatives are accelerated and re-prioritised due to impact of COVID-19, to support and adapt to the future of learning, especially with respect to blended learning. Academic Board noted that further information on this will be provided at the next meeting, as the discussions on the strategy are being finalised.

The Board noted the following matters from the presentation:

- The UTS Performance Report will be provided to Academic Board at the next meeting, which reflects the outstanding work and contribution of UTS staff in the past few months across various initiatives.
- The budgets are currently being revised factoring in COVID-19 impact for 2021 to 2023 (and beyond).
- The Government decision on 'secure corridor' framework is still to be determined, which impacts international students and has financial consequences for the whole sector, including UTS.
- The Board noted an overview of the Fit for 2027 Project Streams, which was developed to consider the COVID-19 impact on the UTS 2027 strategy. The project covers three key areas scale and scope, systems and processes, and operational efficiency.



• While UTS is progressing slowly towards campus reactivation, there may be anxiety on return for some in the community.

The Provost emphasised on the important role of Academic Board in ensuring quality assurance for all UTS courses and ensuring that high quality of learning experience is provided for the students, which is the centrepiece of UTS 2027.

Academic Board commended the tremendous efforts of the UTS staff in transitioning to online learning and continuing to support the UTS 2027 strategy in these challenging times.

# \*3.2 TEQSA Higher Education Standards Framework 2015 (HESF 2015) – COVID-19 update

RESOLVED AB/20-3/44 – TEQSA Higher Education Standards Framework 2015 (HESF 2015) – COVID-19 update

Academic Board resolved to receive and note the report as detailed in Document 3.2 – *Higher Education Standards Framework 2015 (HESF 2015)* – *COVID-19 update*.

#### Note for the record

The Provost noted that the report provides an assessment of UTS's compliance with the Higher Education Standards Framework 2015 in the context of advice provided by the Tertiary Education Quality and Standards Agency (TEQSA) on online delivery as a result of the 2020 pandemic.

The Provost commended the Teaching and Learning Decision Register developed by the Office of Deputy Vice-Chancellor (Education and Students), presented to 20/2 Academic Board. It is an excellent tool to reflect how/why UTS responded to key matters and will assist as a useful record, especially if TEQSA requests such information with respect to COVID-19.

It was noted that as the COVID-19 situation is fluid and Government's decision on secure corridor for international students is yet to be determined, it may be that the online delivery may need to continue beyond 2020. TEQSA advice on online delivery was only applicable to 2020, and further advice will be received from TEQSA on this for 2021.

# \*3.3 UTS student load forecast for 2020

#### **RESOLVED AB/20-3/45 – UTS student load forecast for 2020**

Academic Board resolved to receive and note the report as detailed in Document 3.3 – UTS student load forecast for 2020 and its attachment.



# Note for the record

Professor Andrew Parfitt (Provost) spoke to this item noting that the impact of COVID-19 is reflected in the student load for 2020, with a drop in around 3,500 equivalent full-time student load (EFTSL). The significant loss of revenue (over \$100m in 2020) associated with this result will continue to affect UTS into 2021 and 2022. While domestic demand (from HSC students and non-recent school leavers) may rise, due to the impact of COVID-19 and volatile job market, international demand may continue to suffer, due to border restrictions.

#### \*3.4 Internationalisation (COVID-19)

#### **RESOLVED AB/20-3/46 – Internationalisation (COVID-19)**

Academic Board resolved to receive and note the presentation on Internationalisation (COVID-19).

#### Note for the record

Academic Board received a presentation from the Deputy Vice-Chancellor (International) Mr Iain Watt on Internationalisation (COVID-19). The presentation provided a comparison of international student enrolments in 2019 and 2020, reflecting the impact of COVID-19 and international border closure, which has resulted in a fall in international student numbers and revenue from February 2020 to April/May 2020 (and beyond).

Academic Board noted that there were 14,500 international students in 2019, of which 7,000 were undergraduate and 5,600 postgraduate students – comprising a total of 12,600 full award students, which equates to 10,300 EFTSL (amounts to \$410m revenue in 2020<sup>1</sup> i.e. 35 to 40 per cent of UTS's revenue). Of these 12,600 students, 6,700 were from China and 5,900 from rest of the world. To support continuing student load, UTS needs an intake each year of 5,600 student per annum (i.e. 3,400 in Autumn and 2,200 in Spring).

An overview of the COVID-19 impact as outlined below was noted:

- On 1 February 2020, the China border was closed, which led to 4,000 plus students in China unable to enter Australia (\$80-90m revenue impact). Plus set up of the Hardship fund (3m revenue impact).
- In March 2020, all international borders were closed and UTS moved to remote learning. 4,200 Chinese students were offshore and 700 from other countries.

• In April/May 2020, the revenue impact was revised to \$113m and Hardship fund increased to \$15m.

Academic Board noted the Chinese students' breakdown at end of Autumn Semester, noting that there were not as many withdrawals. 600 deferrals, 1,000 letters of acceptance, 1,300 students completed in Sydney and 2,300 completed in China. 100 students returned to China.

While the environment is fluid and changes occurring constantly, UTS has responded to the needs of the international students by establishing Online Learning Centres in China (three) and Vietnam (one). Summer intake is now allowed for international students.

The Government decision on 'secure corridor' framework is still to be determined. Once the secure corridor is permitted, there may be positive implications, as students may be able to return to Australia, if allowed, for Autumn 2021. Relaxation of rules around post-study work visas for international students impacted by COVID-19 is a welcome move.

Academic Board discussed how UTS would be placed compared to other universities in a post-COVID environment, due to the steps its currently taking in international markets in responding to COVID-19.

The Chair thanked the Deputy Vice-Chancellor (International) for the presentation.

# \*3.5 Student Experience Autumn 2020 (COVID-19)

Academic Board resolved to receive and note the report as detailed in Document 3.5 – *Student Experience Autumn 2020 (COVID-19)*.

#### Note for the record

Academic Board student members provided an overview of their learning experience in Autumn 2020, considering the impacts of COVID-19, specific to each of their respective faculties. Academic Board noted the student feedback (as outlined in the report), which will be considered in decision making for Spring 2020, as appropriate.

In addition to the feedback in the report, it was noted that due to a reduction in students, PhD students who are into casual tutoring at UTS had lost income in some cases, as full time staff are taking over some of these tutoring sessions.

The students emphasised that the articles on LX website on 'What UTS students want from remote teaching' and '7 springs in our step – insights



from student experiences of Autumn session' provided useful insight to support their report.

The Chair thanked student members for providing the report and for the valuable feedback.
