**1 PROCEDURAL MATTERS****1.1 WELCOME/APOLOGIES****RESOLVED AB/21-4/55 – Welcome/Apologies**

Academic Board resolved to note the apologies received from members as noted above and agree that these members be excused for their absence.

**Note for the record**

The Chair opened the meeting with an Acknowledgment of Country and of the Traditional Owners.

The Chair welcomed all members to the meeting (including observers and attendees) and thanked members for attending via Zoom. Student members present introduced themselves.

The Chair acknowledged that this was Professor Attila Brungs' (Vice-Chancellor) last Academic Board meeting. On behalf of the Board, the Chair thanked the Vice-Chancellor for his exceptional leadership and support to Academic Board and for his service to the University.

The Vice-Chancellor thanked Board members for their leadership and acknowledged their service in allowing the university to achieve its objectives.

The Chair welcomed Ms Catherine Livingstone AO (Chancellor) and invited the Chancellor to address the Board.

The Chancellor thanked and expressed appreciation for the service of members of the Board. The Chancellor noted the critical importance of the Board in providing academic leadership to the University by: overseeing the quality of teaching and learning; the quality of the student experience; and the high level of employability of our graduates.

The Chancellor reinforced the importance of:

- the UTS 2027 Strategy, noting that the University is entering the next three-year phase of the Strategy;
- the role of Academic Board is crucial in providing quality assurance to Council in terms of the courses being offered at UTS, not just in the current environment, but also in the future, when elements of the UTS 2027 Strategy are accelerated.

The Chancellor noted that the COVID-19 pandemic has resulted in discontinuity across the tertiary education sector, providing both opportunities and risks to the University. UTS needs to be constantly aware of the opportunities and risks, so that these can be assessed, re-assessed and responded to appropriately. At a national level there are opportunities for UTS to engage with industry. The NSW government is very engaged in the role of universities and what they can

contribute to the State. The Honourable Gabrielle Upton MP has been driving this program. At a federal level, there is a willingness to reset the university/government relationship. There are incredible opportunities for UTS, as a university of technology, to contribute to industry engagement.

The Chancellor advised the Board that we are on track in relation to the search for the new Vice-Chancellor and that Council hopes to make an announcement of the appointment by the end of the year.

The Chair thanked the Chancellor for addressing the Board.

The Chair highlighted the 2021 Forward Plan, the approval of one posthumous degree and the additional executive actions undertaken by the Chair. The Chair and Deputy Chair have visited most of the Faculty Boards to strengthen relationship between the faculties and Academic Boards.

Chair advised the Board of his new elected position as the Chair of the Committee of Chairs of Academic Board (CABS) network. This position will commence in 2022.

The Chair noted that Ms Komal Jagad, Executive Officer (Governance Support) had resigned from UTS and thanked her for the committee support over the years. The Chair welcomed Ms Liezel Swart who is acting in the role.

**Note for the record**

The Vice-Chancellor spoke to his report, highlighting the following and noting that the rest of the report be taken as read.

- **COVID-19 update:** The health and safety of our students, staff and wider community remains our number one priority. It is important to follow the stay-at-home order. It has been decided that the Spring session will continue online until the end of semester. UTS will continue to monitor the NSW government public health advice and update relevant recommendations as appropriate. The full reactivation of the campus will most likely occur in Autumn session 2022.
- **International students:** The NSW Government announced the International Student Arrival Pilot program, which will welcome 500 continuing students back to NSW. Our priority at UTS will only be on bringing continuing students back, so that they can finish their degrees.
- **Congratulations** were extended to:
  - the four finalists of this year's Australian Museum Eureka Prize.
  - the UTS teams that have received the Australian Research Council Linkage Grant, and the Cooperative Research Centre respectively.
  - Professor Hokyong Shon for his work on the industrial transformation research hub in collaboration with the University of Melbourne.
  - Dr Jiao Jiao Li who has won the sixth Falling Walls Lab Australia award.
  - Dr Jean-Baptiste Raina for his work on combining new approaches in microfluids and chemical imaging to identify the cues that govern the behaviour of marine pathogens.
  - all the participants of the Three Minute Thesis competition.
  - to the 2021 recipients of the UTS Alumni Awards
- **Universities Foreign Interference Taskforce:** The Vice Chancellor highlighted the Draft Guidelines by the Universities Foreign Interference Taskforce.
- **Senior Staff Appointment:** The Vice Chancellor acknowledged the new Senior Staff Appointments: Glen Babington – Chief Operating Officer, Professor Carl Rhodes – Dean, UTS Business School, and Professor Debra Anderson – Dean, Faculty of Health.
- **Key Staff Changes:** The Vice Chancellor acknowledged and thanked Glen Rabbitt, Director Facilities Management Office for his outstanding service

after 25 years and wishes him well in his retirement. Professor Lesley Hitchens was acknowledged for her selection as acting Provost starting on the 21<sup>st</sup> of October.

- **University rankings:** The Vice Chancellor acknowledged UTS's performance in the QS world University Rankings and advised that the rise in our ranking is a reflection that we are a global institution.

The Chair acknowledged that this was the Vice Chancellor's final report and thanked him for his leadership and service.

The pilot TD program will start next year, which will introduce transdisciplinary subjects to UTS students. The Provost advised that only one elective subject will be made compulsory in this program.

The faculties and student members have provided feedback and their concerns with the pilot program have been considered.

- measuring student feedback in courses offered in Mandarin needs to be addressed.

The committee is reviewing the course accreditation process with a view to the implementation of systematic, regular reviews of subjects and courses, instead of an annual review.

**Note for the record**

Professor Sara Denize, Chair of Courses Accreditation Committee (CAC) highlighted that the bulk of the committee's work has been on courses reaccreditation. The committee wants to draw the Boards' attention to the compelling case for reaccreditation presented from the Faculty of Law, in relation to the Bachelor of Law and the combined degrees. CAC has been working on helping faculties develop a better approach to preparing for

reaccreditation. The Bachelor of Law's documentation for reaccreditation is well prepared and highlights both strategic and evidence issues.

Professor Sara Denize acknowledged and thanked Associate Professor Annette Gainsford, Associate Dean (Indigenous Teaching and Learning), for her contributions to the work of CAC regarding the implementation of the Indigenous graduate attributes.

The Chair of CAC advised that the committee is working on streamlining the current reaccreditation process, by making the information CAC requires from faculties more evident, for course reaccreditation.

Academic Board noted the 20 new courses, the 20-course reaccreditation, the phasing out and discontinuation of 3 courses, extension of accreditation for 18 courses, and the correction and rescinding of resolutions for Proposal 1675.

### **Note for the record**

Professor Shirley Alexander, Chair of Teaching and Learning Committee (TLC) highlighted two matters in the TLC report:

- the Award Course Approval (ACA) Policy, be updated to provide greater clarity about the approval authority;
- and review process for inherent requirements.

The ACA policy should include references to course “quality” and “viability” rather than “performance”. Performance is currently understood as only the course performance monitored through the Course Performance Report (CPR). Clarification that the use of viability data is also used to trigger the requirement for a business case as part of the reaccreditation process, which allows the CPC to ensure that courses with an average CPR score, but poor viability data are appropriately monitored and reviewed. This has the advantage of improving overall quality of courses.

It is further proposed that the use of the terminology ‘full’ and ‘short’ are discontinued. Course review and reaccreditation is not a short process, rather a significant undertaking which should not be diminished by referring to a “short” reaccreditation. The committee is only going to require a full reaccreditation when course viability becomes a problem.

Professor Shirley Alexander further noted the amendments to the Recognised Prior Learning (RPL) policy. The Academic Community of Recognised Prior Learning Working Group proposed significant changes to the current RPL policy to address the critical challenges noted in the report. The amendments to the policy, proposes to increase intent and process clarity of the RPL policy.

Academic Board noted the recommendations in the report.
