Millions of workers worldwide, are directly affected, including through an epidemic of work-related 'heat stress'. The Too Hot to Work project UTS has been partnering with councils, think tanks and trade unions to advance new research into how to tackle these issues on the ground in workplaces and through policy action.
Emi Otsuji	Everyday multilingualism, Urban multilingualism, Critical applied linguistics, Language ideologies and language education ideologies	The project revolves around everyday multilingualism, taking linguistic ethnographical approach. By focusing on everyday, grassroots, multilingual language use (rather than top-down approaches to ethnolinguistic groups), it explores the ways in which different people, different interactions, and different semiotic and linguistic resources come together at different times and in different places. It challenges common language ideologies around multilingualism, questioning the belief in enumerable and separable languages. This inquiry also has implications for language education ideologies.

Heather Ford and Tamson Pietsch	wikihistories	Wikipedia is one of the most popular websites in the world and the de facto global reference of knowledge about people, places, events and things. Although Wikipedia's scope and authorship are larger than any previous encyclopedia, it nonetheless suffers from significant omissions and misrepresentations. Research on Wikipedia's systemic biases has grown over the past decade, but scholars have not yet systematically addressed either the ways partiality is produced or the platform's approach to historic events. This project aims to address these two gaps, by critically evaluating Wikipedia's representation of people, places and events.

As cities in Australia and abroad continue to grow during changing climates, people's relationships with the environment have been brought to the fore of national and international conversations on and about urban futures. The UN Sustainable Development Goal (SDG) 11, for instance, addresses the challenge of making cities and communities sustainable. The scale of this task can seem immeasurable. Will Visconti	The Material Culture of Nineteenth-Century Urban Sex Work: A Transnational Study	The scope of the project is cross-disciplinary and cross-cultural, to examine the interplay of ideas and influences during the Age of Empire. Cities addressed include London, Paris, Storyville, and Melbourne, with additional examination of sites like Shanghai or Yoshiwara. It argues for a reassessment of sex workers' impact on, and their engagement with, material culture as agents rather than passive consumers or followers. Four key elements of material culture will be addressed: fashion, cosmetics, the spaces of sex work, and the use of technology.
