#2 (	CHECKLIST: Vaccinations	Timing
	I've made an appointment to have my first dose of MMR, varicella and hepatitis B as well as diphtheria tetanus and pertussis (dTpa) by week two of semester.	By the last week in January
	I've obtained a Vaccination Record Card from the Clinical Practice Unit.	By the 1 <sup>st</sup> week in February
	I've checked if I need to have a tuberculosis screening (TST).	By the 1 <sup>st</sup> week in February
	I've had my first dose of MMR, varicella and hepatitis B as well as diphtheria tetanus and pertussis (dTpa), or gathered paperwork proving prior vaccination or sufficient levels of immunity to diseases (where this is possible).	By the 1 <sup>st</sup> week in February
	I've made an appointment to have a TB screening (if needed) at a NSW Health Chest Clinic. I have also scheduled it in to take place one month after receiving my MMR and varicella vaccines.	By the 2 <sup>nd</sup> week in February
	I've made appointment for second doses of MMR, varicella and hepatitis B and scheduled for it to take place no less than 28 days after my first dose.	By the 2 <sup>nd</sup> week in February
	I've had my second dose of MMR, varicella and hepatitis B (if needed).	By the 2 <sup>nd</sup> week in March
	I've made an appointment for my third dose of hepatitis B (if needed) and scheduled for this appointment to take place between two and four months after my second dose, depending on the advice of my GP.	By the 2 <sup>nd</sup> week in March
	I've checked my Vaccination Record Card has been signed and stamped by a GP for every entry and all batch numbers are included.	
	I've had my third dose of Hepatitis B. Note, it may be possible to obtain temporary clinical compliance before having the third dose, providing you've made an appointment for it. However, if your temporary compliance expires before you have obtained your third dose, you will not be allowed to complete your placement.	By the 2 <sup>nd</sup> week of May, depending on advice from your GP.
	I've had my blood test for hepatitis B immunity.	28 days after your third dose
