





Implementation of the Diploma of General Nursing (DGN) and Community Health Worker (CHW) National Curriculums: Strengthening Health Workforce Education in Papua New Guinea

Brief 15: Governance, National Curriculum Steering Committee and Regulation Meetings

June - August 2023

A series of governance and approval meetings for the ongoing 'Strengthening Health Workforce Education In Papua New Guinea' project were held in Port Moresby, in June -August 2023. World Health Organization Collaborating Centre at the University of Technology, Sydney (WHO CC UTS) in partnership with Papua New Guinea's National Department of Health (NDoH), Department of Foreign Affairs and Trade (DFAT) attended meetings with PNG Nursing Council, PNG Medical Board, and Department of Higher Education, Research, Science & Technology (DHERST).

A National Curriculum Steering Committee meeting was also held in June before the newly revised Diploma of General Nursing (DGN) and Community Health Worker (CHW) curriculums were presented for regulation accreditation. The Strengthening Health Workforce Education program aims to support PNG's

health workforce in meeting current and future health needs in the development and implementation of revised National Curriculum for DGN and CHW Programs. Funding was provided by PNG NDoH, the World Health Organization (review) and the Australian Government, through Department of Foreign Affairs and Trade (implementation).

Representatives from NDoH, DHERST and WHO CC UTS held their 4th workshop in Port Moresby, PNG from 12<sup>th</sup> to 23<sup>rd</sup> of June which continued the Health Professional Education Expanded Fast Track Program with PNG CHW and Nursing Educators.

### Senior Executive Management (SEM) Meeting

NDoH HR Training Team presented the program outcomes to the high level Senior Executive Management (SEM) meeting on June 20<sup>th</sup>. The objective of this meeting was to inform SEM of the program progress, prior to

upcoming PNG Nursing Council and PNG Medical Board curriculum approval meetings. The National Curriculum Steering Committee Meeting was then held on June 26th for final approval of the CHW and DGN curriculum documents to report progress and implementation plan prior to meetings with PNG Nursing Council and PNG Medical Board the following day.

## **PNG Nursing Council and Medical Board**

On the 27<sup>th</sup> of June, Prof Michele Rumsey (WHO CC UTS) and Mary Kililo (NDoH) met with the PNG Nursing Council who reviewed the DGN Curriculum documents, Prof Michele Rumsey (WHO CC UTS) and Mary Kililo (NDoH) were then invited to attend a meeting with PNG Medical Board to review the CHW Currriculum documents. During these meetings, the curriculum documents were presented for review, using the NDoH National Curriculum Development Standards for Health programs Checklist.

# Monitoring, Evaluation, Research and Learning (MERL)

Monitoring, Evaluation, Research and Learning (MERL) interviews were conducted between June with the Steering Committee members. These interviews aimed to gain feedback from a range of stakeholders including Nursing and CHW Educators, NDoH, DHERST and DFAT. The feedback received was overwhelmingly positive for the program.

### **Follow up Meetings**

Follow up meeting held with DHERST August 9<sup>th</sup> and NDOH senior management team on August 11<sup>th</sup> to inform them of program progress.
