Expert midwives to build foundation for better maternal health in PNG

Professor John Daly, Head of the World Health Organization Collaborating Centre at the University of Technology, Sydney (WHO CC UTS) and Dean, Faculty of Nursing, Midwifery and Health, UTS would like to announce that AusAID has funded WHO CC UTS and the WHO office in **Papua New Guinea** (PNG) to launch a \$US10 million two year program targeting midwifery education in Papua New Guinea.

PNG suffers from one of the highest maternal mortality rates in the Western Pacific and the Initiative, directed by **Professor Caroline Homer**, aims to accelerate the country's progress towards **Millennium Development Goal 5** for improved maternal health.

Michele Rumsey, Director of Operations and Development, WHO CC UTS, explains that eight international expert midwives will be recruited to work at each of PNG's four midwifery schools, and two regional hospitals will each be assigned with an obstetrician. The teams will provide mentoring and continuous competency development to PNG obstetricians and midwives, as well as assist in the development of educational and practice materials. The expert midwives will work closely with the academic and clinical personnel in the schools and associated hospitals to support capacity-building of educators, clinical supervisors and preceptors.

Emergency and Disaster Competencies in Samoa

The nurses and midwives are the first on sight when an emergency disaster situation arises such as the Samoan tsunami of September 2009.

To help strengthen all practicing nurses in Samoa, technical assistance was provided by Lisa Conlon and Lesley Seaton from **WHO CC UTS**. Working with local nurse leaders in Samoa, the **National Competencies for Emergency and Disaster Nursing and Midwifery** were documented; and a curricular framework for courses in emergency and disaster nursing/midwifery developed. Also the facilitation of a train the trainers course with the Faculty of Nursing at the National University of Samoa was undertaken.

A New Faculty Development Survey

A faculty development study is being conducted at the **WHO CC UTS** and is funded by the **World Health Organization's Western Pacific Regional Office**. The study is focusing on the current trends and future needs of education and Faculty Development programs for Nurses, Midwives and other health professionals living and/or working in the Western Pacific and South East Asian regions.

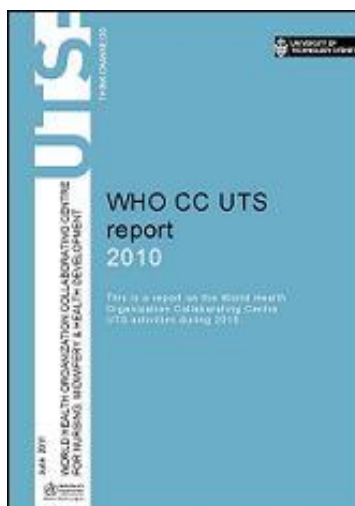
